NOTICE OF ADR REFERRAL

Pursuant to the inherent powers of this Court, Uniform Superior Court Rule 1.2 and Department of Transportation v. City of Atlanta, et al., the above-styled case has been referred to the Alternative Dispute Resolution Program of the Cobb County Superior Court. The parties have the opportunity to select either: **Case Evaluation or Mediation**.

The parties have until February 3, 2022, to select their preferred ADR process, select their neutral, schedule their ADR conference, and notify the ADR office of their decision.

Enclosed is the listing of certified neutrals from which to select. If the ADR office has not received this information by the above date, or the parties cannot reach an agreement on the type of ADR process, it will default to Mediation. A mediator, date and time for mediation will be scheduled for you which may not be changed absent good cause shown. Technically, it is the Plaintiff's responsibility to schedule an ADR conference; however, upon agreement, anyone may schedule the conference by either by calling the ADR office at (770) 528-1812 or emailing the ADR coordinator assigned to the case.

The Supreme Court ADR Rules require that all domestic relations cases be screened to determine if a mediation session can be done safely. Please click on the link below and complete all case and contact information on the first screen and answer all questions to the best of your ability.
