<u>AGREEMENT</u>

- 1. This NATO Standardization Agreement (STANAG) is promulgated by the Director NATO Standardization Agency under the authority vested in him by the NATO Standardization Organisation Charter.

AIM

1. The aim of this agreement is to register national acceptance of AMP-3(A) Volume II, including Changes 1 through 11.

AGREEMENT

- 2. Participating nations agree to use AMP-3(A) Volume II, including Changes 1 though 11, as a manual for NATO Mine Delivery Systems.
- 3. Participating nations agree to forward any corrections or additions to their national information, to the custodian each year; they will be incorporated in the AP without being offered to other nations for agreement. Changes to the format or general information sections will not be incorporated until they have been formally offered by the MC Maritime Standardization Board (MCMSB), NSA to national authorities concerned and have been agreed by them.

IMPLEMENTATION OF THIS AGREEMENT

4. This STANAG and AMP-3(A) Volume II, including Changes 1 through 11, are considered ready to be implemented when they have been received by the authorities and units concerned.
