EXPLANATORY NOTES

AGREEMENT

- 1. This NATO Standardization Agreement (STANAG) is promulgated by the Director NSA under the authority vested in him by the NATO Military Committee.
- 2. No departure may be made from the agreement without consultation with the tasking authority. Nations may propose changes at any time to the tasking authority where they will be processed in the same manner as the original agreement.
- 3. Ratifying nations have agreed that national orders, manuals and instructions implementing this STANAG will include a reference to the STANAG number for purposes of identification.

DEFINITIONS

- 4. <u>Ratification</u> is "In NATO Standardization, the fulfilment by which a member nation formally accepts, with or without reservation, the content of a Standardization Agreement" (AAP-6).
- 5. <u>Implementation</u> is "In NATO Standardization, the fulfilment by a member nation of its obligations as specified in a Standardization Agreement" (AAP-6).
- 6. <u>Reservation</u> is "In NATO Standardization, the stated qualification by a member nation that describes the part of a Standardization Agreement that it will not implement or will implement only with limitations" (AAP-6).

RATIFICATION, IMPLEMENTATION AND RESERVATIONS

7. Page iii gives the details of ratification and implementation of this agreement. If no details are shown it signifies that the nation has not yet notified the tasking authority of its intentions. Page iv (and subsequent) gives details of reservations and proprietary rights that have been stated.

<u>AIM</u>

1. The aim of this agreement is to register national acceptance of AMP-14 including Changes 1 through 4.

AGREEMENT

- 2. Participating nations agree to use AMP-14 including Changes 1 through 4 as a manual for degaussing and all other forms of electromagnetic silencing.
- 3. Changes to AMP-14 will be incorporated into the publication and will be accepted as part of it provided they have been formally offered by the Naval Board to national authorities concerned and have been agreed by them.

IMPLEMENTATION OF THE AGREEMENT

4. This STANAG and AMP-14 including Changes 1 through 4 are considered ready to be implemented when the Change has been received by the authorities and units concerned.
