AIM

1. The aim of this agreement is to register national acceptance of ANEP-82

AGREEMENT

- 2. Participating nations agree to use the specifications in ANEP-82 to provide a common interface between allied ships Combat Management Systems (CMS) and the NATO FORACS Integrated Data Acquisition Test System (IDATS).
- 3. Changes to ANEP-82 will be incorporated into the publication and will be accepted as part of it provided they have been formally offered by the NATO Naval Armamants Group to national authorities concerned and have been agreed by them.

IMPLEMENTATION OF THE AGREEMENT

4. This STANAG and ANEP-82, are considered ready to be implemented when they have been received by the authorities and units concerned;
