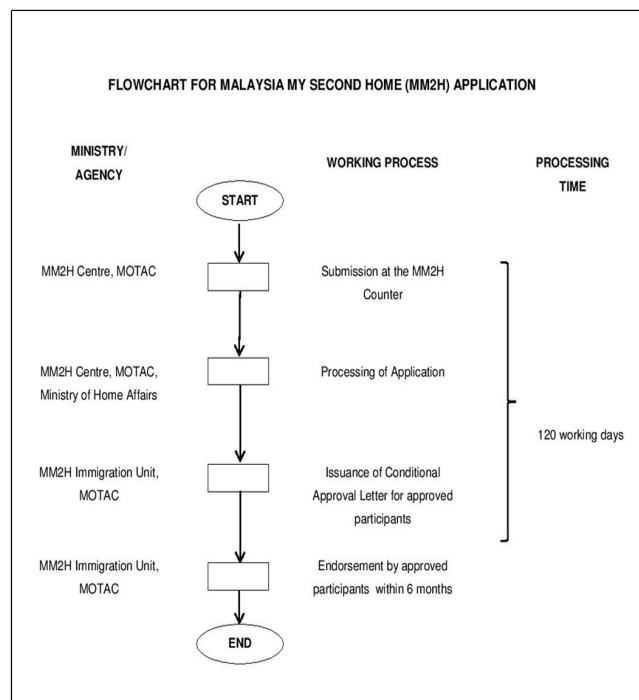


FLOWCHART FOR MALAYSIA MY SECOND HOME (MM2H) APPLICATION

What is MM2H Programme ?

The Malaysia My Second Home (MM2H) Programme is an initiative by the Government of Malaysia to attract foreigners who fulfill certain criteria, to stay in Malaysia on Social Visit Pass with Multiple Entry Visa. The Social Visit Pass is initially for a period of ten (10) years, and is renewable.

Why Malaysia My Second Home ?

- 1) **10 Years Renewable Visa (T&C Applied)**
- 2) **Off-shore Income Not Taxable**
- 3) **Allowed To Employ Foreign Domestic Helper From Own Country (T&C Applied)**
- 4) **Allowed To Purchase Residential Property**
- 5) **Allowed To Work Part Time (T&C Applied)**
- 6) **Investment Opportunities**

Who are eligible ?

It is open to all foreigners age 21 years old and above, from countries which have diplomatic relations with Malaysia regardless of race, religion, gender or age. Applicants are allowed to bring their spouses and unmarried children below the age of 21 as dependents.

How to Apply

- 1) Direct Application
- 2) Through MM2H Licensed Agent

Terms And Conditions

Upon Application

a) Financial Requirements

- **Applicants aged 50 years & above**
Liquid assets of RM 350,000 & monthly off-shore income of RM 10,000
- **Applicants below 50 years**
Liquid assets of RM 500,000 & monthly off-shore income of RM 10,000

b) Letter of Good Conduct

Terms And Conditions

Upon Approval

- Approved applicants will be issued a Conditional Approval Letter where they are required to comply with the following requirements within a 6 months period :

1) Open a Fixed Deposit Account in Malaysia

- Applicants aged 50 years & above : **RM 150,000**
- Applicants below 50 years : **RM 300,000**

2) Pay Immigration Related Fees

*For Social Visit Pass & Multiple Entry
(Journey performed visa where applicable)

3) Pay Security Bond (For Direct Applicant)

4) Must Possess Health Insurance

5) Must Produce Medical Report From Local Hospital or Clinic

6) Endorsement must be settled within 6 months from the date of Conditional Approval Letter
